Budget Amendment** 26 27 Donations-PD (General Fund Revenue Account No. 000.364.20) is hereby increased by 28 \$3,500.00 for receipt of donated furniture for the City of Central Police Department. 29 30 Furniture & Fixtures-PD (General Fund Expenditure Account No. 000.421.05.743) is hereby increased by \$3,500.00 to record of the donation of furniture received by the City of 31 32 Central Police Department. 33 34 **Section 2. Conflicts** 35 The specific terms and conditions of this Ordinance shall prevail against prior ordinances 36 37 of the City to the extent there is any conflict. 38 39 **Section 3. Severability** 40 41 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect 42 the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. 43 44 The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall 45 remain in force and effect.
