**ORDINANCE NO. 2018-23**

**AN ORDINANCE TO AMEND THE 2018-2019 FISCAL YEAR BUDGET TO APPROPRIATE FUNDS APPLIANCES FOR THE POLICE DEPARTMENT AND TO PROVIDE FOR RELATED MATTERS**

WHEREAS, the Council for the City of Central received a donated building located at 13505 Hooper Road from East Baton Rouge Parish in August 2016; and

WHEREAS, the City of Central Police department is in the process of renovating and relocating to the building located at 13505 Hooper Road; and

WHEREAS, the expenditures for the appliances were included in the 2017-2018 Fiscal Year General Fund Budget;

WHEREAS, the appliances were not received and installed until July 2018;

WHEREAS, the Council for the City of Central did not include the expenditures for the appliances for the City of Central Police Department in the 2018-19 Fiscal Year Budget; and

WHEREAS, the Council for the City of Central desires to amend the 2017-2018 Fiscal Year Budget to properly appropriate necessary funds related to the above-stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

**Section 1.** Furniture & Fixtures-PD (General Fund Expenditure Account No. 000.421.05.743) is hereby increased by \$2,700.00 to provide for expenditures to purchase appliances for the City of Central Police Department.

**Section 2. Conflicts**

The specific terms and conditions of this Ordinance shall prevail against prior ordinances of the City to the extent that there may be any conflict.

**Section 3. Severability**

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of

the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

**Section 4. Effective Date**

This Ordinance shall be effective upon publication.


