ORDINANCE NO. 2019-38

AN ORDINANCE TO AMEND THE 2019-2020 FISCAL YEAR BUDGET FOR THE CAPITAL OUTLAY & IMPROVEMENT TO APPROPRIATE UP TO \$149,160 FOR PRELIMINARY ENGINEERING SERVICES FOR STATE PROJECT H.013546 / FEDERAL AID PROJECT NO. H013546 (THIBODEAUX ROAD IMPROVEMENTS) AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, the Council and Mayor of the City of Central desire to make certain improvements to Thibodeaux Road from Morgan Road to Planchet Road including but not limited to road patching and overlaying and construction of closed drainage along Thibodeaux Road, (“Thibodeaux Road Project”);

WHEREAS, by Ordinance No. 2019-12 the Council for the City of Central amended the 2018-2019 Fiscal Year Half Cent Special Revenue Fund to transfer funds to the Capital Outlay and Improvement Fund for preliminary engineering services for State Project No. H013546 / Federal Aid Project No. H013546 to improve Thibodeaux Road;

WHEREAS, the funds appropriated for State Project No. H013546 / Federal Aid Project No. H013546 were not expended during the 2018-2019 fiscal year; and

WHEREAS, the Council for the City of Central desires to amend the 2019-2020 fiscal year budget to fund the local match for State Project No. H013546 / Federal Aid Project No. H013546 to improve Thibodeaux Road.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Budget Amendment

Increase HC – Road Construction (Capital Outlay & Improvement Expenditure in Account No. 210-431.10.730), \$149,160 to pay the cost of preliminary engineering services for State Project No. H013546 / Federal Aid Project No. H.013546.

Section 2. Conflicts

The specific terms and conditions of this Ordinance shall prevail against prior ordinances of the City to the extent there is any conflict.

Section 3. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4. Effective Date

This Ordinance shall be effective upon publication.
