7 AN ORDINANCE TO AMEND THE 2019-2020 FISCAL  
8 YEAR GENERAL BUDGET TO APPROPRIATE  
9 ADDITIONAL FUNDS FOR GENERAL LIABILITY  
10 INSURANCE FOR THE POLICE DEPARTMENT BY \$4,100  
11 AND TO PROVIDE FOR RELATED MATTERS  
12

13 WHEREAS, the Council for the City of Central did not include sufficient funds within the  
14 2019-2020 Fiscal Year General Budget for General Liability Insurance for the City of Central  
15 Police Department; and  
16

17 WHEREAS, the Council for the City of Central desires to amend the 2019-2020 Fiscal  
18 Year General Budget to appropriate funds necessary related to the above stated matters.  
19

20 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of  
21 Louisiana as follows:

23 **Section 1. Budget Amendment**  
24

25 Insurance-Liability (General Fund Expenditure Account No. 000.421.05.520) is hereby  
26 increased by \$4,100.00 to provide sufficient funds for liability insurance coverage for the City of  
27 Central Police Department.  
28

29 **Section 2. Conflicts**  
30

31 The specific terms and conditions of this Ordinance shall prevail against prior ordinances  
32 of the City to the extent there is any conflict.  
33

34 **Section 3. Severability**  
35

36 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a  
37 court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the  
38 validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The  
39 remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain  
40 in force and effect.

42 **Section 4. Effective Date**

44 This Ordinance shall be effective upon publication.
