7 AN ORDINANCE TO AMEND THE 2019-2020 FISCAL YEAR
8 CAPITAL OUTLAY & IMPROVEMENT BUDGET TO
9 APPROPRIATE \$6,000 FOR DESIGN SERVICES FOR SITE
10 SELECTION FOR A CITY HALL BUILDING AND TO
11 PROVIDE FOR RELATED MATTERS

13 WHEREAS, the City of Central was awarded a grant from the State of Louisiana for the
14 construction of a City Hall;
15

16 WHEREAS, the City of Central expects to receive grant payments related to cost of a City
17 Hall Building from the State of Louisiana;
18

19 WHEREAS, the City of Central 2019-2020 Fiscal Year Capital Outlay & Improvement
20 Fund Budget State Grant Revenue Account No. 210.334.30 reflects the balance available related
21 to the awarded grant funds for the construction of a City Hall; and
22

23 WHEREAS, the Council for the City of Central desires to amend the 2019-20 Fiscal Year
24 Capital Outlay & Improvement Fund Budget to appropriate necessary funds related to design
25 services for preparation of materials for site selection for a City Hall Building.

27 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
28 Louisiana as follows:

30 **Section 1. Budget Amendment**

31
32 Buildings (Capital Outlay & Improvement Fund Expenditure Account No. 210.400.10.000) is
33 hereby increased by \$6,000.00 to provide for expenditures related to the design services for site
34 selection for a City Hall Building.

36 **Section 2. Conflicts**

38 The specific terms and conditions of this Ordinance shall prevail against prior ordinances of the
39 City to the extent there is any conflict.

41 **Section 3 Severability**

43 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of
44 competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of
45 the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of

1 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
2 effect.
