ORDINANCE NO. 2018-21

AN ORDINANCE TO AMEND THE 2018-2019 FISCAL YEAR BUDGET TO APPROPRIATE FUNDS FOR THE RECEIPT OF A DONATION OF POLICE UNIT FOR THE POLICE DEPARTMENT AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, the Council for the City of Central did not include within the 2018-19 Fiscal Year General Budget for the City of Central Police Department, receipt of a donation for a 2009 Chevy Tahoe Police Unit by the City of Central Police Department and related expenditures to put the police unit in services; and

WHEREAS, the Council for the City of Central desires to amend the 2018-2019 Fiscal Year General Budget to properly appropriate funds necessary related to the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Vehicles-PD (General Fund Expenditure Account No. 000.421.70.742) is hereby increased by \$15,730 to provide for the donated 2009 Chevy Tahoe Police Unit and related expenditures of painting and equipment for the City of Central Police Department.

Section 2. Insurance-Vehicles (General Fund Expenditure Account No. 000.421.05.742) is hereby increased by \$832 to provide for insurance coverage on the donated 2009 Chevy Tahoe Unit.

Section 3. Donations-PD (General Fund Revenue Account No. 000.364.20) is hereby increased by \$12,525 for the donation received related to the 2009 Chevy Tahoe Police Unit by the City of Central Police Department.

Section 4. Conflicts

The specific terms and conditions of this Ordinance shall prevail against prior ordinances of the City to the extent that there may be any conflict.

Section 5. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of

the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 6. Effective Date

This Ordinance shall be effective upon publication.






