ORDINANCE NO. 2018-14

AN ORDINANCE TO AMEND THE 2017-2018 FISCAL YEAR BUDGET TO APPROPRIATE FUNDS FOR BUILDING RENOVATIONS AND RELOCATION EXPENDITURES FOR THE POLICE DEPARTMENT AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, the Council for the City of Central received a donated building located at 13505 Hooper Road from East Baton Rouge Parish in August 2016; and

WHEREAS, the City of Central Police department desires to relocate to the building located at 13505 Hooper Road; and

WHEREAS the relocation of the City of Central Police Department requires renovation of the building located at 13505 Hooper Road and relocation expenditures related to specific equipment of the City of Central Police Department; and

WHEREAS, the Council for the City of Central did not include the renovation and equipment relocation expenditures for the City of Central Police Department in the 2017-18 Fiscal Year Budget; and

WHEREAS, the Council for the City of Central desires to amend the 2017-2018 Fiscal Year Budget to properly appropriate necessary funds related to the above-stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Building Construction (Capital Outlay & Improvement Fund Expenditure Account No. 210.400.10.000) is hereby increased by \$94,900.00 to provide for renovation expenditures for the building located at 13505 Hooper Road.

Section 2. Transfer from General Fund (Capital Outlay & Improvement Fund Revenue Account No. 210.391.00.100) is hereby increased by \$94,900.00 to receive funds from the General Fund to cover expenditures related to the renovation of the building located at 13505 Hooper Road.

Section 3. Transfer to Capital Outlay & Improvement Fund (General Fund Expenditure Account No. 000.491.21.200) is hereby increased by \$94,900.00 to transfer funds to the Capital Outlay & Improvement Fund to cover expenditures related to the renovation of the building located at 13505 Hooper Road.

Section 4. Repairs & Maint-Vehicles & Equip PD (General Fund Expenditure Account No. 000.421.70.430) is hereby increased by \$9,400.00 to provide for the expenditures related to equipment relocation to the building located at 13505 Hooper Road for the City of Central Police Department.

Section 5. Furniture & Fixtures-PD (General Fund Expenditure Account No. 000.421.05.743) is hereby increased by \$2,700.00 to provide for expenditures to purchase appliances for the City of Central Police Department.

Section 6. Conflicts

The specific terms and conditions of this Ordinance shall prevail against prior Ordinances of the City to the extent that there may be any conflict.

Section 7. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 8. Effective Date

This Ordinance shall be effective upon publication.






