13 14 15 16 17	Section 7. Adjustments. The Mayor is hereby authorized to adjust line items of expenditures within a program or function of a department. Such adjustments shall be reported to the City Council. To the extent actual expenditures exceed the amount appropriated by 5% or more in any fund, the Mayor shall recommend a budget amendment to the City Council for approval as required by the Louisiana Local Government Budget Act, La. R.S. 39:1201 <i>et seq</i> .
19 20 21 22 23	Section 8. Severability. If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.
25	Section 9. Effective Date. This Ordinance shall be effective on July 1, 2020.
