**ORDINANCE NO. 2018-43**

**AN ORDINANCE TO AMEND THE 2018-2019 FISCAL YEAR GENERAL FUND BUDGET TO APPROPRIATE FUNDS FOR A NEW COMPUTER FOR CITY HALL AND TO PROVIDE FOR RELATED MATTERS**

WHEREAS, the City of Central has been experiencing performance issues with the existing computer utilized by the administrative assistant and desires to replace it by purchasing a new Dell Tower and Monitor; and

WHEREAS, the City of Central did not include funds in the 2018-19 Fiscal Year General Fund Budget for the purchase of a new computer; and

WHEREAS, The Council and Mayor desires to amend the 2018-2019 Fiscal Year General Budget to appropriate funds for the purchase of a computer for use by the administrative assistant and to provide for the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

**Section 1.** Equipment-City (General Fund Expenditure Account No. 000.410.00.741) is hereby increased by \$1,320.00 to provide the purchase of a new Dell Tower and Monitor.

**Section 2. Conflicts**

The specific terms and conditions of this Ordinance shall prevail against other Ordinances of the City to the extent that there may be any conflict.

**Section 3. Severability**

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

**Section 5. Effective Date**

This Ordinance shall be effective upon publication.






