ORDINANCE NO. 2018-29

AN ORDINANCE TO AMEND THE 2018-2019 FISCAL YEAR GENERAL FUND BUDGET FOR THE RECEIPT OF LGAP GRANT FUNDS FOR THE CITY OF CENTRAL POLICE DEPARTMENT AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, the City of Central applied for the 2014-15 and 2015-16 LGAP Funds to be utilized for the City of Central Police department equipment needs;

WHEREAS, the City of Central was awarded grand funds for the 2014-15 LGAP Grant in the amount of \$4,390 and for the 2015-16 LGAP Grant in the amount of \$6,000;

WHEREAS, the City of Central completed approved purchases related to these LGAP grants in July 2018 and submitted required documentation for reimbursement to LGAP;

WHEREAS, the City of Central did not include the receipt of the 2014-15 LGAP funds or the 2015-16 LGAP funds in its 2018-19 General Fund Budget;

WHEREAS, The Council and Mayor desires to amend the 2018-2019 Fiscal Year General Budget to for the receipt of these LGAP funds related to the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Grants-Police Department (Revenue Account No. 000.334.12) is hereby increased by \$10,390.00 to provide for the receipt of the 2014-15 and 2015-16 LGAP funds.

Section 2. Conflicts

The specific terms and conditions of this Ordinance shall prevail against other ordinances of the City to the extent that there may be any conflict.

Section 3. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4. Effective Date

This Ordinance shall be effective upon publication.




