ORDINANCE NO. 2018-49

AN ORDINANCE TO AMEND THE 2018-2019 FISCAL YEAR GENERAL FUND BUDGET TO APPROPRIATE FUNDS FOR UPDATING THE MASTER PLAN, LAND USE MAP AND ZONING MATTERS AND TO PROVIDE FOR RELATED MATTERS.

WHEREAS, The Council of the City of Central recognized a need and desired to update the Master Plan, Land Use Map, and Zoning matters;

WHEREAS, the Council determined that the cost of updating the Master Plan, Land Use Map, and Zoning matters will be \$70,000;

WHEREAS, the Council appropriated funds in prior fiscal years and did not expend all funds originally appropriated related to updating the Master Plan, Land Use Map, and Zoning matters in those budgets;

WHEREAS, the Council recognizes that previously appropriated funds related to this project that were not expended in prior fiscal years should be included in the current fiscal year budget; and

WHEREAS, the Council for the City of Central desires to amend the 2018-2019 Fiscal Year General Fund Budget to properly appropriate necessary funds related to the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. City Planner Services (General Fund Account No. 000.418.20.330) is hereby increased by \$4,237.50 to provide for the expenditures related to updating the Master Plan, Land Use Map, and Zoning matters that were not expended in prior fiscal years.

Section 2. Conflicts

The specific terms and conditions of this Ordinance shall prevail against prior ordinances of the City to the extent that there may be any conflict

Section 3. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of

the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4. Effective Date

This Ordinance shall be effective upon publication.






