7 AN ORDINANCE TO AMEND THE 2019-2020 FISCAL
8 YEAR BUDGET TO APPROPRIATE ADDITIONAL FUNDS
9 FOR OCCUPATIONAL LICENSE REFUNDS AND TO
10 PROVIDE FOR RELATED MATTERS

12 WHEREAS, the Council for the City of Central did not include sufficient funds within the
13 2019-20 Fiscal Year General Budget for refunds related to Occupational License;

14
15 WHEREAS, the Council for the City of Central wishes to increase the refund account in
16 the 2019-20 Fiscal Year General Budget to allocate funds accordingly; and

17
18 WHEREAS, the Council for the City of Central desires to amend the 2019-2020 Fiscal
19 Year General Budget to appropriate funds necessary related to the above stated matters.

21 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
22 Louisiana as follows:

24 **Section 1.** Refunds-Occupational License (General Fund Expenditure Account No.
25 000.415.65.310) is hereby increased by \$20,500 to provide sufficient funds for Occupational
26 License refunds.

28 **Section 4. Conflicts**

30 All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

32 **Section 5. Severability**

34 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of
35 competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of
36 the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of
37 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
38 effect.
