**CITY OF CENTRAL
ORDINANCE NO. 2018-19**

**AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR
TO EXECUTE A CONTRACT FOR CITY SERVICES WITH
THE INSTITUTE FOR BUILDING TECHNOLOGY AND SAFETY
THROUGH JUNE 30, 2023; AND TO PROVIDE FOR RELATED MATTERS**

WHEREAS, the City of Central and the Institute for Building Technology and Safety (“IBTS”) entered into a Contract for City Services (“Contract”) in June 2011;

WHEREAS, the Contract, including executed extensions thereto, provides for service performance through June 30, 2018;

WHEREAS, in early 2018, the City of Central sought and received proposals from potential contractors to provide City Services from July 1, 2018 through June 30, 2023;

WHEREAS, on January 9, 2018, the Mayor recommended, and the Council of the City of Central agreed, that the City enter into a new five-year contract with IBTS to provide City Services;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1: The Council for the City of Central hereby authorizes and directs the Mayor of the City of Central to execute the contract for City Services with IBTS for a five year term, effective from July 1, 2018 through midnight on June 30, 2023, Central Standard Time, in accordance with the Contract.

Section 2: The specific terms and conditions of this Ordinance shall prevail against other ordinances of the City to the extent that there may be any conflict.

Section 3: Severability. If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4. Effective Date. This Ordinance shall be effective upon publication.






