ORDINANCE NO. 2016-47

AN ORDINANCE TO AMEND THE 2016-2017 FISCAL YEAR BUDGET TO APPROPRIATE FUNDS FOR ARCHITECT FEES RELATED TO THE DESIGN OF A CITY HALL BUILDING AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, the Council for the City of Central was awarded a grant from the State of Louisiana for the construction of a City Hall; and

WHEREAS, the Council for the City of Central wishes to allocate funds for the design of a City Hall Building and that funds for this purpose were not provided in the 2016-17 Fiscal Year Capital Outlay & Improvement Fund Budget;

WHEREAS, the Council for the City of Central desires to amend the 2016-2017 Fiscal Year Capital Outlay & Improvement Fund Budget to appropriate necessary funds related to the above-stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. State Grants-Capital (Capital Outlay & Improvement Fund Account No. 210.334.30) is hereby created and increased by \$6,000.00 to provide for grant funds to be received from the State of Louisiana for the purpose of construction of a City Hall Building.

Section 2. Buildings (Capital Outlay & Improvement Fund Account No. 210.400.10.000) is hereby created and increased by \$6,000.00 to provide for expenditures related to the architect fees for the design of a City Hall Building

Section 3. Conflicts

The specific terms and conditions of the Ordinance shall prevail against prior ordinances of the City to the extent that there may be any conflict.

Section 4. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 5. Effective Date

This Ordinance shall be effective upon publication.




