**ORDINANCE NO. 2015 -26**

AN ORDINANCE AMENDING THE GENERAL FUND BUDGET AND THE DEDICATED FUND BUDGETS FOR THE EMERGENCY SERVICES, DRAINAGE, AND LOCAL ROAD IMPROVEMENT & MAINTENANCE FUND FEES, THE HALF CENT SALES AND USE TAX AND THE TRAFFIC CONTRIBUTION FUNDS FOR THE 2014-2015 FISCAL YEAR AND PROVIDING FOR RELATED MATTERS

WHEREAS, The City of Central adopted General Fund Budget and the Dedicated Fund Budgets for the Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fees, the Half Cent Sales and Use Tax and the Traffic Contribution Funds for 2014-2015 (“the Budgets”); and

WHEREAS, The Budgets for the 2014-2015 Fiscal Year need to be amended to include certain income received and expenses incurred since the adoption of the Budgets in order to comply with the Local Government Budget Act.

THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana:

**Section 1. Budget Amendments.** The General Fund Budget and the Dedicated Fund Budgets for the Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fees, the Half Cent Sales and Use Tax and the Traffic Contribution Funds for 2014-2015 are hereby amended as shown in Exhibit A – City of Central Budget 2015-16 attached hereto.

**Section 2. Conflicts.** All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

**Section 3. Severability.** If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

**Section 4. Effective Date.** This Ordinance shall be effective upon publication in the Official Journal.




